Access to inspect the property and NV plots continued to be restricted in 2021/’22 due to the ongoing Covid ’19 Pandemic.

Melbourne was in a State Gov. directed lockdown (#3) from 13th Feb., 2021 to 17th Feb. 2021, totalling 5 calendar days.

Lockdown (#4) extended from Friday May 28 ’21, to Thursday, 10 June ’21, totalling 14 calendar days.

Lockdown (#5) extended from Friday 16 July, ’21 to Tuesday 27 July ’21, totalling 12 calendar days.

Lockdown (#6) extended from Thursday 5 August to Thursday 21 October, ’21, totalling 77 calendar days.

The lockdown aggregated to a total of 103 calendar days during this reporting period, further frustrating inspections and activities on site.

With continued uncertainty regarding lockdowns it was impossible to plan and undertake onsite actions, considering the seasonal requirements for certain activities.

Small Farm Contracting undertook noxious weed spot spraying for serrated tussock, in and around the sth. east plot. See appendix ~~2~~ attached.

The extent of volunteer phalaris, was becoming an issue. It was likely that a controlled burn would be required in the near future. We decided to allow sheep onto this plot for an extended period to reduce some biomass prior to the burn, attempting to create the right biomass conditions for a ‘cold’ burn. This would be undertaken in winter and early spring of ’22. *Note: 3 x images of phalaris extent in sth East plot. Appendices 2, 3 & 4.*

Fencing and gates were routinely inspected, when able, complying with the various lockdowns. The inspections were undertaken by either a representative of MG Pastoral or a sub-contractor, Small Farm Contracting. Specifically, the integrity of the rabbit proof fence of the SRF plot in the nth. east corner, was a particular focus. Again, there were no noticeable penetrations nor deficiencies with the integrity of the fence. The southern boundary fence remains in good stock proof condition.
